- 1.2** We are a company limited by guarantee.
- 1.3** We are regulated by the following Bahrain Regulation regulators:
  - 1.3.1** Legislative decree no. (25) Of the year 1998 with respect to: private educational and training institutions.

### Accessing Our Site

- 1.4** Access to our site is permitted on a temporary basis, and we reserve the right to withdraw or amend the service we provide on our site without notice (see below).
